<u>Forms and Procedures:</u> Parents agree to supply Oak Tree Academy with the necessary forms to register and enroll their child.

Parents agree to sign their child in and out every day they attend, along with the times they drop off and pick up, and they agree to notify the office in writing when another authorized person will be picking up the child.

Parents are expected to be prompt at release times for the child. If unsure of the time, check with your child's teacher or the Director. I agree to comply with these times and will pay any late fees occurred by the end of the month.

Oak Tree Academy is licensed by the Department of Social Services of the State of California and that agency has the right to perform the duties specified by law, including visits to the school site and the checking of any and all records.

I understand that if the days, times or program of my child's enrollment changes, my tuition fee may change. I understand that if I wish to change any aspect of my child's enrollment, I must give 2 weeks written notice to the Director. A new Registration Agreement may need to be completed as well. Oak Tree Academy may terminate the agreement if the parents fail to comply with any of its provisions.

I understand that I am responsible for payments on the days that my child may not attend and that there is no reimbursement for vacations, holidays or illness. I understand that Oak Tree Academy will be closed for the following Holidays, Staff Development days and Vacations and I am not entitled to a credit for these days:
